#### PRESIDENT'S REPORT 2012-2013

MEDICAL BENEVOLENT ASSOCIATION OF NSW

President's Report 2013

The Medical Benevolent Association of NSW has been providing assistance to doctors, their families and others for 117 years now.

"Then suddenly at 38 I'm the patient and I'm the doctor ... What now?" This was the headline of our last Annual Appeal. We wanted to remind doctors that medical training doesn't make them immune to ill-health and that help is at hand if they find themselves in the position of patient rather than doctor.

Over the last financial year we have continued to work on having adequate resources to make urgent financial contributions when a doctor is unable to support themselves and their family. We have continued with the intention to ensure that every doctor in NSW and ACT knows that help is available if needed. We are also continuing to remind every doctor that it is essential to have a financial survival plan if ill health strikes.

The cost of living continues to increase and requests for assistance have also increased. Our treasurer has noted in his report, the income from our investments has by no means returned to the pre-global economic slowdown level. Subsequently we have had to reduce the level of our assistance to all and encourage longer term recipients to become financially independent. However, we continue to provide the necessary assistance in any acute situation or new crisis.

We are thankful to our donors, both individual and groups. We are encouraged by the fact that the number of group donors has started to increase. This helps to offset the impact of unstable investment income. We are especially thankful to have some long term donors who have been even more generous during this difficult financial time. It is still disappointing though that only a small portion of doctors donate to the Association. If every doctor in NSW and the ACT donated just \$20.00 each we would have sufficient funds to meet our beneficiaries' current annual need.

#### 2012-2013 has been a busy year for the Association once again.

#### **On matters of Governance:**

We undertook ATO self-assessments of our Deductible Gift Recipient and Tax Concession Charity Australian Tax Office Status.

Our Fundraising License from Office of Liquor Gaming and Racing was renewed.

Our Account signatories were reviewed and updated.

An Asset Review was undertaken.

All Policies were reviewed to ensure compliance and a Receipt register and Financial Reserves Policy were approved for use. In addition ASIC registers are routinely reviewed and Council nomination forms amended to reflect the date of review.

A new data collection tool was developed.

#### In the area of Education/information:

The practice of reviewing a journal article at each meeting continues.

The Social Worker has attended seminars on Family Law and Grief Counselling. In order to ensure compliance with the new Charities regulator- Australian Charities and Not for Profits Commission (ACNC) the Social Worker attended an Understanding Financial Reports workshop, a Moore Stephens ACNC workshop and both our Social Worker and Finance Officer attended the Tress Cox ACNC workshop

#### In relation to Partnerships and Networks:

Our Social Worker continues to represent us on the Management Committee of the Doctors Health Advisory Service (DHAS NSW) as its Hon Secretary.

MBANSW was included in the Northern Sydney Medicare Local consortium bid for the Partners in Recovery program.

More recently we have had discussions with Holman Webb solicitors who have kindly offered to provide pro bono legal advice for our beneficiaries.

#### With regards to Service Promotion:

We have had articles and advertisements in NSW and Canberra Doctor Magazines, in the Northern Sydney Medical Local online newsletter, and in NSW Doctor to coincide with the Beyond Blue survey of Doctors' mental health.

A series of articles have been published in Royal Australian and New Zealand College of Radiologists Journal Inside News on doctors support services, managing workplace stress and identifying and responding to a colleague in distress. In addition, an article on 'Workplace relationships' was published in Insight, the online journal of the Medical Journal of Australia. Information about MBANSW was included in the NSW Rural Doctors reference book. The Bequest Brochure was reviewed, updated, reprinted and sent to our regular donors. Our Social Worker conducted an information seminar for the staff at Invivo Insurance. Brochures were sent to AMANSW Intern Orientation day and to AMA ACT for their subscription renewal letters.

#### In the area of Finances:

We have maintained the practice of rigorously reviewing our income and expenditure each month and now include in this review a monthly portfolio snapshot. After some protracted discussions with our bank and comparing fees and services with some of the other major banks we have adopted electronic banking for our Business Account (Current Account). This has involved the use of electronic 'signatures'. The process of paying accounts will be a more timely process and give the electronic signatories easier access to scrutinise accounts.

#### TREASURER'S REPORT 2012-2013

Mr President, fellow councillors, Ladies and Gentlemen,

I hereby present the audited Financial Report for the Medical Benevolent Association of NSW for the financial year ended 30th June 2013.

During this financial year the aims of the Association have been to both provide assistance to our beneficiaries and to make sure that it will remain financially viable in the future. This was necessitated by the recent global financial crisis and the resultant reduction in our assets. Last year our total accumulated funds amounted to \$1,832,345 which has increased to \$2,002,033. This increase has been mainly due to a positive return in our investments which has been very welcome.

In the last financial year we spent \$207,260 on our beneficiaries, which included \$49,354 of social work assistance. Our expenditure on beneficiaries has decreased from \$269,456 in 2012. Despite the reduction we have been diligent in maintaining our core function of meeting our beneficiaries' essential needs.

Donations have always been the Association's main source of income. This year donations from individuals and groups amounted to \$221,819 which was a small reduction on last year's donations of \$243,658. For the first time for several years donations have covered beneficiary expenses. We are most grateful for the generosity of our donors as in the past we have had to make up the shortfall by drawing on investments.

We had a net operating surplus of \$195,514 this year which was a reduction from last year of \$254,397. The reduction was mainly due to profits on disposal of investments in the last financial year of \$57,299 which totalled \$2,215 this year. The impairment of assets this year was \$10,584 which was similar to the impairment loss in the previous year of \$9,668. I note that due to the timing of invoices in this financial year some \$18,000.00 of appeal expenses will be accrued in the next financial year.

My thanks to my fellow councillors for their dedication to our colleagues in need and the financial health of the Association. Thanks again this year to Meredith McVey (Social Worker) and Danielle Doughty (Financial Officer) for their help in managing the accounts. This year we have started the process of changing to online banking which will streamline processes and give us more timely access to financial information.

#### SOCIAL WORKER'S REPORT 2012 - 2013

As you are aware, I wear two hats in my work for the Medical Benevolent Association of NSW. The first and probably most important hat that I wear is the Association's social worker. I am the first person a distressed doctor or family member speaks to and I maintain contact with them until they are 'back on their feet' or at least on safer ground. As the difficulties doctors face are many and varied, so too is my work. As we have found at council, making rules and regulations about 'who, when, for how long and how much' is not an efficient use of time. The great strength of the Association is its ability to adapt its response to individual needs. But I digress.

Whenever possible I meet face to face with those needing assistance to get a clear picture of their financial and support needs. I help them to understand the process of requesting financial assistance and completing paperwork. This discussion, of necessity covers confidentiality and privacy. We also look at other resources such as Centrelink, legal, industrial and financial counselling which are available. If urgent or ongoing specialist assistance is required I try to facilitate access to services. I then maintain contact as necessary. For some, daily telephone contact is needed until specialist treatment is arranged and for others, contact is left to their discretion.

At present there are 134 members of the medical family receiving assistance, either financial and/or social work support from the Association. For the past few years referrals have remained at an average of 2 new referrals per month. This year requests for assistance from male doctors have outweighed requests for assistance from female doctors. This is a departure from previous years when gender seemed not to make a difference. On the occasion that a member of a doctor's family rings to ask for assistance (less than one quarter of referrals are from family members), it is always a female who makes contact. Continuing last year's trend, the requests for counselling assistance alone have outweighed the requests for financial assistance. This may be due to some of the promotional activities undertaken this year, but hopefully it is a sign that doctors are seeking help sooner and have taken out income protection insurance.

The average age of all who requested assistance this year is 48. General Practitioners are more likely to ask for assistance than colleagues from other specialities. However, doctors in training, make up one third of requests for assistance this year. This number is higher than in previous years. All who ask for assistance are facing difficulties in several areas of their life, so referrals are seldom for one reason. This year, unlike last year, referrals which name mental health difficulties as the main reason for contacting MBANSW have outnumbered referrals for physical health and work related matters. Depression and bipolar disorder are two conditions which are most often cited as affecting those who have asked for assistance.

Having trained as a doctor overseas seems to remain a factor for referral as does having some contact with the NSW or ACT Medical Councils. Referrals where a doctor is struggling with substance abuse have increased this year having dwindled to almost nothing in previous years.

A significant aspect of the social work role is one of advice, support and referral. On average there are 2 calls per week (or contacts through the website) seeking referral advice. These phone calls may come from the doctor themselves, a friend, colleague, manager/ supervisor or a family member. They are not counted in our 'numbers' unless ongoing assistance, either financial or counselling, is required. Occasionally, but rarely they involve one contact and can take anywhere from 5 minutes to 5 hours. To provide a snap shot, in a week period, I received calls asking for assistance with resources for a doctor's health presentation, from a deregistered rural GP needing urgent mental health assistance, a doctor whose colleague had been assaulted at work, a JMO seeking relationship counselling and the family member of a GP distressed about his deteriorating mental health.

The other hat I wear is that of Executive Secretary of the MBANSW. A large part of my Executive Secretary role is governance, as an Income Tax Exempt Charity with Deductible Gift recipient status we have responsibilities to the Australian Tax Office, ASIC, Office of Liquor, Gaming and Racing and Australian Charities and Not for Profits Commission (ACNC). It seems that every year there are new compliance requirements. We are committed to having an efficient, effective and transparent organisation and I believe the ongoing review of practices and procedures will stand us in good stead for future requirements.

My association with the Doctors Health Advisory Service continues. I was again elected as the Hon Secretary. The close relationship between the two organisations is essential. This year I was again fortunate to have the opportunity to present information on the work of the Association at the international Health of Health Professionals Conference in Brisbane.

There are many who make my work as the Executive Secretary so much easier.

My deep gratitude to Danielle Doughty the Finance officer. Danielle is capable, efficient and wonderfully supportive. Together, we tackle the boring bits and support each other through the frustrating bits. Thank you Danielle for keeping me and the Association on track.

Thanks also to Fiona Davies and her staff at AMANSW. Fiona and her senior legal and industrial staff always provide a willing ear and sound advice when I am struggling with a complex work matter for one of our beneficiaries. Fiona makes many opportunities for promotion of MBANSW, through links to our website, the *NSW Doctor* journal, or in person at the careers day, junior medical officer manager's forum and men's health promotion or through the distribution of our brochures. Fiona's staff are welcoming and inclusive.

Bill Nussbaum of HLB Mann Judd has also provided sound advice to council about measures to make MBANSW more financially efficient and effective. Bill and his staff are endlessly patient with my many queries.

I would like to express my thanks to the Councillors and acknowledge the generosity of their spirits. I often comment that the doctors on council are the most compassionate and least judgmental group of people I have ever worked with. The doctors who ask us for assistance are usually in great distress, sometimes of their own making, but often not. Discussion at Council meetings always takes into account the emotional impact of the situation and focusses on how to make things better; it is never dismissive of a doctor's situation. All on council make themselves available at any hour of the day and night to provide advice, assistance and consider and approve an urgent request.

My particular thanks to the President, David Chen, whose calm reasoning and tolerance of my interruptions I find invaluable.

And finally an acknowledgment of the courage many of our beneficiaries and their families demonstrate and of the difference our donors make to their lives.
